



Waiver, Release, and Indemnity Agreement

As a condition of the above-named participant (“Participant”) being allowed to participate in the GROVE YOUTH SOCCER LEAGUE (“League”) with The Grove Community Church (“The Grove”), I voluntarily and absolutely release and discharge The Grove, and its officers, agents and employees, from any and all losses, damages, actions or causes of action resulting from participation in the League; whether or not such injuries or damages are caused by negligence (active or passive). I will indemnify and hold harmless The Grove and its officers, agents, servants or employees (“Indemnitees”) from any and all claims or causes of action by any person or entity, and under no circumstances will present any claims against Indemnitees for personal injury, property damage, or wrongful death.

I understand that participating in the League involve serious risks and I assume all risks related to Participant’s involvement, including but not limited to risks not known to me or not reasonably foreseeable at this time. The League may involve strenuous physical activity, and I understand the very nature of the game of soccer is hazardous, including, but not limited to, the acts of kicking, heading and fielding the ball, colliding with other players or objects, being struck by balls, running, jumping, sliding, falling, and being kicked or struck by other players, all of which may result in serious and/or permanent physical injury or death. I voluntarily accept all risks of injury (a) while practicing or playing, (b) while serving in a non-playing capacity during practice or play by others, and (c) while on the premises of any field. I understand The Grove does not make any warranties relating to safety or condition of any facility, field, or walkway, and I am solely responsible for Participant’s safety. I consent for Participant to receive, and authorize The Grove staff and participants to use their discretion to administer medical care and/or treatment. I hereby authorize medical services to be rendered and I agree I will pay for all costs thereof. I understand there are risks associated with any medical procedure and I agree to assume the risks. I certify Participant is in good health and condition, and is able to safely participate in the League. I am responsible for determining whether Participant is physically and medically able to participate in the League and/or any other activities related to the League.

I understand an inherent risk of exposure to COVID-19 exists in any public place where people are present and that such risks are significant despite any precautions which may be taken. I understand COVID-19 is an extremely contagious disease that can lead to severe illness and death. I consent for Participant to participate in the League and I voluntarily assume all risks related to exposure to COVID-19, including but not limited to exposure from contagious participants coaches, referees, and/or staff, and exposure caused by any individual’s failure to follow any infection safety practice.

My signature below certifies approval for Participant’s image and voice to be recorded, videotaped, and/or photographed by The Grove for use in any of The Grove’s publications, including on the internet, without compensation therefor.

I understand the terms and legal consequences of signing this Agreement. This Agreement extends to claims and facts unknown and unsuspected to exist at the time of executing this Agreement. All rights under Section 1542 of the California Civil Code are hereby expressly waived with respect to any of the claims, injuries, or damages described in this Agreement. Section 1542 of the California Civil Code reads: A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR. I acknowledge the foregoing waiver and release is an essential and material term, without which The Grove would not let the Participant take part in the League. I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I AM SIGNING AS AN AUTHORIZED PARENT/LEGAL GUARDIAN AND NO OTHER PARENTAL CONSENT IS REQUIRED BY LAW.
